TO ALL MEMBERS:

TRIENNIAL GENERAL ELECTIONS OF SBI OFFICERS' ASSOCIATION, CHANDIGARH CIRCLE FOR THE TERM 2021-2024

The election committee was appointed by SBI Officers' Association, Chandigarh Circle which was circulated vide Circular No. 2021/57 dated 12.07.2021. The election committee has accepted the responsibility of conducting the elections in a fair & transparent manner. We solicit the support and cooperation of one and all to enable us to live up to the expectations of the Central Committee.

- 2. All the members of the association posted in circle/deputation/posted in other circles are eligible to participate in the elections process and required to observe the discipline. The members on without pay due to sabbatical, study, medical leave etc. will also be eligible to take part in the process subject to satisfaction of Election Committee. For the purpose of preparing the list of members, the subscription for the month of July 2021 will be considered.
- 3. The Contestants as well as Proposer and Seconder for the Module/Zonal posts shall at the time of nomination necessarily be posted within the jurisdiction of the Administrative Office (Module) concerned and those for the Regional posts within the jurisdiction of the Regional Business Office (Region) concerned.

For the purpose of Electoral Process, the members posted in

- i) All Branches and other establishments like BPR cells, SAMB, SAARC, Special branches (including Mid-Corporate Branches), SBILD, SBLC, RACCs, DAC, CCPC, LCPC, Anytime Channel, SARB, Circle Procurement Department, SAMB, GOC, Mid Corporate Offices, ZBOs and RBOs will form the part of respective Region and Module in which they are geographically established. The branches/other establishments at a centre where more than one RBO is located will be the part of RBO as furnished in "Annexure 1" of this circular. The contestants, as well as proposers and seconders for the post of Asstt. General Secretary (Kashmir Valley) shall pertain to Jurisdiction of RBO-I & RBO-4, Srinagar and only the members of these two RBOs as detailed in "Annexure-I"will vote for Asstt. General Secretary (Kashmir Valley). The members will vote for Circle office-bearers also in addition to Zonal and Regional office bearers.
- ii) Members posted in LHO, and outside the Circle will vote for the Circle Office bearers only.

5. <u>ELECTION PROCESS</u>:

The process of election has commenced and is likely to be completed by last week of September, 2021. However, the process may be extended depending upon the exigencies of circumstances, pandemic conditions and the consequent restrictions imposed by the Central/State/District Authorities or as decided by the Election Committee. The decision of Election Committee will be final and binding in all matters relating to election process.

6. NOMINATIONS:

- i) The nominations/withdrawals as per specimen enclosed "Annexure-2" shall be sent/delivered in a sealed cover addressed to the Chairman of the Election Committee. Each candidate must mention in the nomination form, the post (Circle/Zonal/Regional) to which he/she is seeking election as well as his/her place of posting.
- ii) The nomination for the posts of Circle Office Bearers shall be proposed by minimum one member from each Module of the Circle and similarly seconded by minimum one member from each Module. To amplify this provision further, as currently there are 7 Modules, all the Contestants for posts of Circle office bearers shall be proposed and seconded by minimum 14 members.
- iii) Any proposer or seconder can propose or second a maximum number of as many candidates for a particular post as notified for that post. To elaborate and simplify the point, a member can propose or second only one candidate for the post of President. Similarly, a member can propose or second not more than 4 candidates for the post of Circle Vice President, 2 candidates for the post of Circle Dy. General Secretary, 3 candidates for the post of Organising Secretary and so on.
- iv) The nomination for the posts of Module Office Bearers including Zonal Committee Members shall be proposed by minimum one member from each Region of the Module and similarly seconded by minimum one member from each Region of the Module. The nomination for the post of Asstt. General Secretary (Kashmir Valley) shall be proposed by minimum one member from Region 1 & Region 4 Srinagar each and similarly seconded by minimum one member from Region 1 & Region 4 Srinagar each.
- v) The nomination for the post of Regional Secretary shall be proposed by one member and seconded by another member posted within the Region from where the election is sought to be contested.

- vi) The contestants for the posts of Circle Office Bearers shall deposit a refundable amount of Rs.10,000/- (Rupees Ten thousand only) with the Election Committee as a security deposit. Similarly, the contestants for the post of Module Office bearers shall deposit a sum of Rs.5000.00 (Rupees Five thousand only). The nominations shall be summarily rejected if not accompanied by the aforementioned security deposit (payable by Banker's Cheque/Draft in favor of SBI Officers' Association, Chandigarh Circle). The Said deposit shall be refunded in case the contestant withdraws the nomination on or before the last day notified for withdrawal of nominations. However, the deposit shall be forfeited in case the contestant polls less than 10 percent of the total valid votes polled, applicable to her/his constituency, in her/his favor. All disputes in relation to this provision shall be referred to the Election Committee whose decision shall be final and binding.
- vii) All the nominations shall be sent in a sealed cover addressed to the Chairman of the Election Committee.
- viii) On the day scheduled for the purpose by the Election Committee here-in-below, a list of valid nominations, under the signatures of the Chairman of the Committee shall be published.
- ix) As per clause 61 of Bye-laws and Rules of Association, any member who does not participate in a strike call or has marked her/ himself as on duty on the day of the said strike call of the SBIOA/AISBOF/AIBOC or any Body/Group/Association of which the SBIOA/AISBOF is a part of shall be considered ineligible to contest the election to any post of the Association at the Circle and/or the Zonal level.
- 7. **ELECTION SCHEDULE:** Our Circle comprises of three States and three Union Territories. On account of pandemic ravaging the country, Government and Local Administration across the states have clamped and continuing restrictions to congregate and hold events and gatherings. Further, there is likelihood that the country may experience a third wave in coming months. In this backdrop, the Election Committee has decided to take a pragmatic view at each stage after reviewing the impact of pandemic in different States/UTs and accordingly polling and counting schedule will be communicated in due course.
